Aloha Kakou,

The smell of desperation is never good, especially the foul smell of evil permeating from the Office of Hawaiian Affairs and the offices of Kana'iolowalu. Having spent millions of dollars, with events where no one showed up, and gathered a paltry 20,000 signatures, OHA and the Roll Commission now know that the people have rejected their attempt to create a nation-within-a-Nation.

More and more the people have come to understand the kuleana created by the signatures our Ancestors placed on the Ku'e Petition, a kuleana to never agree to the destruction of our Nation. The people have come to understand that restoration of the Nation is the only truly Pono path for the future.

When faced with obvious defeat, OHA and the Roll Commission first attempted to steal signatures from other petitions. Then they threatened people into signing the roll by claiming anyone not signing would lose their status as Kanaka Maoli and their right to participate in or benefit from the creation of a new subordinate nation.

When the threats blew up in their face and people from every sector condemned their abuse, OHA and the Roll Commission grew even more desperate. Now I am receiving reports from around the Kingdom that Kana'iolowalu representatives are going to craft fairs, convalescent homes, Kupuna retirement homes and their private residences, telling them that before they die they can leave behind a legacy, that they restored the Nation to its full independence if they would but sign their palapala. Deception lurks at every level, by telling the Kupuna that the plan is for a restored nation, rather than the truth of a planned nation-within-a-nation. All of which is simply a lie. In addition, we hear that the Roll Commission representatives are asking the Kupuna if there are other members of the family and then adding those names to the roll without permission of those whose names are being used.

With a brief visit to the website Kanaiolowalu.org., the heading "Un-relinquished, Undeterred, and unified to rebuild the Hawaiian Nation.", is false! Creating a semi-autonomous governing entity under the authority of the United States Interior Department is NOT rebuilding "the Hawaiian Nation."

Watch for the sliding panel with the quote "Because I'm Hawaiian [I'd] like to see us become self-governed like we're supposed to be for over 120 years." ...Really? Putting people of Hawaiian ancestry on a reservation when their nation is still occupied by the United States is hardly self-governance like we had before the overthrow.

The lie about the true purpose of Kana'iolowalu is at the heart of a scheme to commit fraud. Let's take a look at that legal term, which is defined as follows: ***Fraud is generally defined in the law as an intentional misrepresentation of material existing fact made by one person to another with knowledge of its falsity and for the purpose of inducing the other person to act, and upon which the other person relies with resulting injury or damage. Fraud may also be made by an omission or purposeful failure to state material facts, which nondisclosure makes other statements misleading.***

When OHA and Kana'iolowalu tell their lie that the intent of the Roll Commission is to “rebuild the Hawaiian nation” and that lie gets people to sign the petition, those who sign are being deceived into working against the restoration of the nation and acting in a manner that could end up denying the restoration that they desire.

Also, the failure to state clearly that the Roll Commission intends to follow the nation-within-a-Nation scheme is an omission that makes the other statements by the Kana'iolowalu representatives misleading.

The bottom line is that public funds intended to be used for the benefit of the Hawaiian people are being used to deceive people of Hawaiian descent into signing away their birthright. There is obviously no shame within OHA or the Roll Commission.

I urge everyone to warn the Kupuna about the fraudulent actions targeting them and their families.

The Kingdom is restored, thus the acts by the agents of the occupying power continue to descend to desperation. They have exhibited that their occupation survives only as an outlaw state.

Hao ko al aka makani la, pau loa. With one great sweep of wind, all is gone. All the work our ancestors have done in signing the Ku'e and the many sacrifice's they endured would be lost if each of you continue down the path of starving us from being an independent nation. For the order of the day for OHA and the Roll Commission is to destroy our independence by creating a nation within a nation. This is not what independence means. If you sign their palapala, you sign away our inherent right of being Our Own Nation – The Kingdom of Hawai'i.

Make no mistake, I am the King. I shall do everything within my heart to right the substantial wrongs and bring our Nation into the light where it belongs. ***Mālama ka po'e,***
