### **About our Speakers:**

**Professor Angela Campbell** is a member of the faculty staff of the Institute for Public Representation, Georgetown Law (IPR). She joined IPR in February 1988, and is head of IPR's First Amendment and Media Law Project. She graduated from UCLA School of Law in 1981 where she was editor-in-chief of the Federal Communications Law Journal. She spent two years as a Graduate Fellow at IPR, where she concentrated in the communications area and argued two cases before the U.S. Court of Appeals for the D.C. Circuit. After leaving IPR, she worked as an associate at the firm of Fisher, Wayland, Cooper & Leader, and as an attorney at the Communications and Finance Section of the Antitrust Division, U.S. Department of Justice. While at the Justice Department, she was involved in enforcing the consent decree in *U.S. v. AT&T*, filing comments with the FCC and investigating mergers.

**Gerald Kato** is an Associate Professor of Journalism at the University of Hawaii's School of Communications where he specializes in Broadcasting and Media Law. Prior to joining the faculty, he was a political reporter at KGMB-TV and KITV in Honolulu. He has worked as a courts and government reporter at The Honolulu Advertiser and as a general assignment reporter for The San Bernardino (CA) Sun. He is the recipient of a National Endowment for the Humanities Journalism Fellowship at the University of Michigan and the Hawaii Chapter of the Society of Professional Journalist's First Amendment Award.

**Chris Conybeare** is a television journalist and documentary producer with more than 28 years of production experience. He is a 1970 graduate of the Case Western Reserve University School of Law. Chris has practiced in Hawai'i since 1979 with special focus on human and civil rights, as well as certain aspects of media law. He is on the faculty of the Center for Labor Education and Research, UH West Oahu and has served as president of the Media Council Hawai'i since 2004. He also serves as Secretary General of the World Association of Press Councils (WAPC), headquartered in Istanbul Turkey.
